Waste Transfer Station: Response from Donna: No further response from City of Gold Coast

Behms Road Stop Signs: Further to the request from the Jacobs Well Progress Association for the installation of stop signs on Behms Road at the intersections with Pimpama-Jacobs Well Road and Staplyton-Jacobs Well Road, Council's Traffic branch advise that "Stop" signs are only installed where visibility on the approach to an intersection is restricted to the extent that it is deemed unsafe for motorists to proceed without stopping completely. The use of stop signs where poor sight distance is not a factor can lead to driver disobedience and a lack of credibility of stop signs by motorists. For a road with an 80km/h speed limit, a stop sign can only be installed if the available sight distance falls below 65m. Following an onsite inspection it was identified that there is a minimum of 180m visibility for drivers exiting Behms Road onto Pimpama-Jacobs Well Road. As such, the Transport and Traffic Branch does not support changing the existing give way sign to a stop sign at the intersection of Behms Road and Pimpama-Jacobs Well Road.

In relation to the request for a stop sign at the intersection of Behms Road and Stapylton-Jacobs Well, this request has been forwarded to the Department of Transport and Main Roads (TMR) as this intersection is under their jurisdiction. TMR have been requested to forward a response to your office directly."

Cr Gates office will update you further once we receive a response from DTMR on their investigations.

Bus Services to Jacobs Well, E-petition: Principal Petitioner (Michael Crandon Principal Sponsor)? Lindy Salter has agreed to be the Principal Petitioner. E-petitions on member for Coomera www site. Donna Gates exspressed that an E petition is a waste of time and that council is looking into a cab service as this is more effective. Donna will continue to work on this.
